LAWRENCE COUNTY CAREER AND TECHNICAL CENTER TEAM WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

1. In consideration for the use of the _____ at 750 Phelps Way, New Castle, PA _____ High School (Team) hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE Lawrence County Career and Technical Center, their officers, servants, agents, administrators, and employees (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by an athlete, or to any property belonging to the athlete, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise, while participating in such activity, or while in, on or upon the premises where the activity is being conducted or in transportation to and from said premises.

2. The team acknowledges that each player listed on the attached list of participants has a fully executed parental authorization to participate, and the Team will maintain a copy of the authorizations and will provide the authorizations to the Releasee upon request. The participants have had a physical as required by the school district and has signed all necessary waivers and releases required by school policy and public school law.

3. To the best of Team's knowledge, the athlete can fully participate in this activity. He/she is fully aware of risks and hazards connected with the activity, including but not limited to the risks as noted herein, and I hereby elect to voluntarily participate in said activity, and to enter the above-named premises and engage in such activity knowing that the activity may be hazardous. The Team VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE, OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by the athlete, or any loss or damage to property owned by the athlete, as a result of being engaged in such activity, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES or otherwise.

4. The Team further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASEES from any loss, liability, damage or costs, including court costs and attorney's fees, that may incur due to my participation in said activity, WHETHER CAUSED BY NEGLIGENCE OF RELEASEES or otherwise.

5. It is the Team's express intent that this Release and Hold Harmless Agreement shall bind the members of the athlete's family. The Team hereby further agrees that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of Pennsylvania.

6. THE TEAM UNDERSTANDS THAT THE LAWRENCE COUNTY CAREER AND TECHNICAL CENTER WILL NOT BE RESPONSIBLE FOR ANY MEDICAL COSTS ASSOCIATED WITH AN INJURY THE ATHLETE MAY SUSTAIN.

7. THE TEAM ALSO UNDERSTANDS THAT THE TEAM IS RESPONSIBLE FOR ANY DAMAGE THE ATHLETE MAY CAUSE TO THE FACILITIES.

8. THE COACH, TEAM, AND ALL ATHLETES SHALL COMPLY WITH THE ATTACHED RULES.

IN SIGNING THIS RELEASE, I _____ (Athletic Director), ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my/our own free act and deed; no oral representations, statements or inducements, apart from the foregoing written agreement, have been made; I do hereby execute this Release on behalf of the school district for full, adequate and complete consideration fully intending to be bound by same.
